### **Understanding Elder Abuse**

## **About the Training Institute**

Every year, it is estimated that 1 in 20 older Americans (age 60+) falls victim to some form of mistreatment or neglect.

### **Types of Elder Abuse:**

- Physical
- Psychological or Emotional
- Sexual
- Financial
- Neglect
- Abandonment

### **Signs of Potential Elder Abuse:**

- Unexplained injuries including bruises, cuts, broken bones
- Fear of speaking in front of a particular caregiver or "new friend"
- Dramatic changes in hygiene, appearance, mental status
- Depression and/or anxiety
- Becoming secretive and elusive
- Family prevented from communicating or visiting with loved one
- Frequent trips to the ER

Thousands of older adults in New York are abused, neglected, and exploited every year, and the number is growing. JASA's Elder Abuse Training Institute is an interdisciplinary program, which improves the understanding of and response to the various forms of elder abuse. The Institute educates social service, health, legal, and financial professionals as well as the public.

Hoarding Disorder:
A Community Approach

This workshop focuses on red flags that indicate the presence of possible abuse or exploitation. Participants will learn best practices for addressing abuse and working effectively with victims. Information will be provided on how to work with clients who are victims of financial exploitation and scams.

Participants will gain a better understanding of hoarding disorder, a specified psychiatric disorder, from the practical, legal, and clinical perspective.

Participants will learn about self-neglect as a component of elder abuse and its impact in hoarding cases as well as the safety and health issues that can accompany hoarding behavior. Participants will also learn about the philosophy and strategy of a Harm Reduction approach and "reasonable accommodations" within the scope of the Disability and Fair Housing Acts.

# Workshop #4 Innovative Perspectives in Elder Abuse Interventions: Working with Victims and Perpetrators

This workshop addresses the impact of elder abuse on immigrants who do not have lawful status in the United States. Participants will learn about potential immigration protections and benefits for survivors of elder abuse. In addition, legal immigration consequences for abusers will be discussed.

This workshop highlights new approaches to services for both victims of elder abuse and the perpetrators. Participants will learn intervention techniques including employing the "Life Event Screening Tool," which helps identify trauma to help older victims address their own victimization. In this workshop, participants will also learn about the S.E.A.M. program (Stop Elder Abuse and Mistreatment) that tries to provide a "third alternative" to holding elder abusers accountable, yet achieving interventions that older victims will accept. This unique program confronts perpetrators about their abusive behaviors and attempts to facilitate change to prevent further abuse.
